Generating Essential Evidence

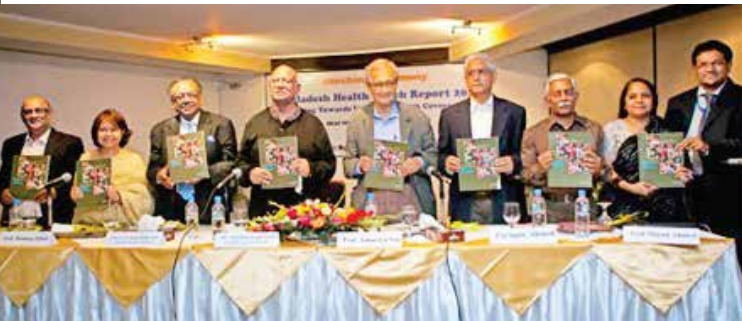
- Policy briefs and systematic reviews on key determinants of coverage including workforce, governance, and information system
- Identifying irregularities and informal practices and its effect on health systems performance
- Measures of coverage for financial protection and service delivery
- Studying models and key functions of insurance systems including service provider networks, service packages, premiums, benefits and claims management
- Implementing research on UHC initiatives with real-time monitoring and evaluation

Developing Core Competencies

- Conduct comprehensive needs assessment with key implementing institutions
- Provide new training opportunities for UHC:
 - customized short courses on specific topics, e.g. introductory course on UHC, health care financing, claims management, purchaser-provider split, scientific writing
 - Bangladesh flagship course on health systems and Universal health coverage
- Develop accredited training programmes and short courses
- Expand opportunities for Faculty in doctoral and postdoctoral studies

Advocacy

- Build a forum for advancing UHC
- Joint learning dissemination with local, global, and development partners
- Convening national and international workshops, seminars, and dialogues on key UHC issues
- Develop links with peer institutions



Why Bangladesh Needs Universal Health Coverage?

- “Health is more of an investment than a cost.”- WHO
- Government’s global commitment for UHC by 2030
- High out-of-pocket (OOP) expenditures

Challenges

- Mobilising resources for UHC
- Inadequate health workforce and skill-mix imbalance
- Rapid rise of Non-Communicable Diseases (NCDs)
- Lack of responsiveness in health system

Opportunities

- MDGs related to health are achieved
- Global commitment for achieving SDG 3 (target 3.8) which endorses Universal Health Coverage
- Consensus growing around UHC in the region and globally (World Health Assembly Resolution 2011)
- The Ministry of Health and Family Welfare, Government of Bangladesh drafted Health, Nutrition and Population Strategic Investment Plan (HNPSIP) which aims to ensure that quality health services are delivered and key services are provided more effectively, focusing on equity, efficiency and quality
- The Government of Bangladesh set UHC as one of the targets in its 7th Five-Year Plan (FY2016 – FY2020) for the health, nutrition and population sector to achieve its Vision 2021
