Dr. Zahidul Quayyum is a health economist and a public health researcher and has more than 25 years of experiences of conducting health economics and health systems research. His research interests include: evaluating different policy changes in health care from health economics and health systems and development perspective; equity and resource allocation in health care; economic evaluation of health care interventions and health technology assessment. He has more than 10 years of experiences of teaching health economics in the UK universities including the University of Glasgow, University of Aberdeen, University of Dundee and the Queen Mary University of London. He has worked as a Health Economist in many projects national and international projects and has been mainly involved in working on economic evaluation models for safe motherhood interventions strategies and the economic analysis of government interventions and policy changes for improving maternal and child health in Indonesia, Ghana, Burkina Faso, and in Bangladesh. He has also been involved in conducting within trial economic evaluation, systematic review of economic evaluation, decision modelling and health technology assessment for the NIHR (UK) funded and commissioned by NICE, UK, and EU funded projects in the UK. He teaches Health Economics and Health Care Financing, and Health Systems in the Master of Public Health (MPH) Programme at the BRAC JPG School of Public H, BRAC University. Besides teaching, he is currently leading four research projects as Principal Investigator (PI) and three as Co-Investigator. His expertise is in economic evaluation, decision modelling, mixed methods research, and health systems research. His research work mainly focuses on maternal and child nutrition, social determinants of health and sexual and reproductive health, and health of the displaced and marginalized population.

Dr. Quayyum authored more than 40 publications, many of them published in highly reputed international peer-reviewed journals including *Health Policy Planning*, *Health Technology Assessment*, *International Journal for Equity in Health*, *BMJ Open*, *BMJ Global Health and European Journal of Health Economics* etc.
